3. Reports

Reports: A. Finance Report

Matt Ferreira reviewed the Finance Report. We estimate nearly \$1 million to be available at the end of this fiscal year with some year-end activities expenses to reduce the amount slightly.

Board Chair Marsh asked for an explanation on how the amount returned to the town helps the taxpayers. It was learned that the amount returned to towns offsets the tax rate based on property valuations. The financials will closed June 30th. The audit is to be done in August with preliminary numbers in September but not finalized until the following spring.

4. Continuing Business

Information: A. Administrative Update on the Return to School Task Force

Dr. Lupini reported on the Joint Board briefing on Monday evening, a Tuesday morning briefing was held for the employees followed by a joint briefing with SAU 90 for the community in the evening. The main message received is that families want their kids to go back to school. We plan on conducting a survey to gather more information from parents, students and staff with questions such as are they comfortable coming back to school? Will they use school transportation? Does a hybrid model work for them? What type of hybrid? Everyone will have the opportunity to answer the survey multiple times and also for each student they may have in teh schools as the answers may differ depending on the age of their child(ren) and what school(s) they attend.

The Board reviewed the meeting calendar for the upcoming year. No meetings are currently scheduled for July but a briefing for the Joint Board will be scheduled as needed.

The plan is to present the budget to school board by October 16th and then to the Budget Committee by November 20th. The Deliberative Session is scheduled for February 4th. The Budget Committee schedules the public hearing date.

Board member Delano questioned to budget process in regard to financial planning for 2021-2022 considering we are in the midst of the pandemic and the 2020-2021 hasn't yet started. Matt Ferreira confirmed that although the process itself is normally a challenge this year will be even more so in light of the pandemic and trying to be even more fiscally conservative due to the economic struggles the communities are experiencing.

Chairman Marsh discussed the August meeting being held "in house" and showing the community that the Board is coming together as the school is expected to do.
